CYBERSECURITY AND BUSINESS INTELLIGENCE

1.- COMPLIANCE WITH CYBERSECURITY REGULATIONS

EU regulatory environment: NIS Directive. Corporate and individual criminal liability: digital crime control systems.

2.- CYBER THREATS

Cyberspace as a risk factor for companies. Main cyber threats.

The weakest link: Users. Sources of vulnerability. Attack vectors (Attached files, Phishing, Social engineering). Attack on WIFI, Attack on wired infrastructure. Control over access points. Trojans and keyloggers, downloading of malware software. Community Manager in the company (Website, Trojans, interposed proxies, social networks, access protection, password change policy).

3.- CYBERSECURITY PLANNING

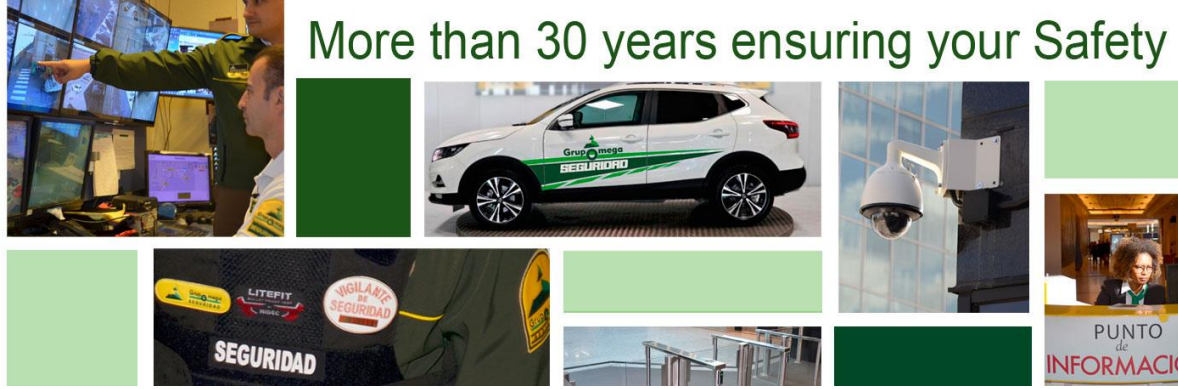
Developing the Corporate Cybersecurity Policy: Contingency plans and information security plans. Basic cyber defense measures. Backing up information (backup plan) Virus protection and software control. Network control. Physical protection of network access.

4.- GENERAL ARCHITECTURE OF INFORMATION AND COMMUNICATIONS SYSTEMS

Inside and outside the business world, to be able to know what software, hardware and communications are used in your establishment and what are the main and common vulnerabilities.

5.- INTERNAL RISK: INFORMATION LEAKAGE

7.-SOCIAL ENGINEERING AND INFLUENCE

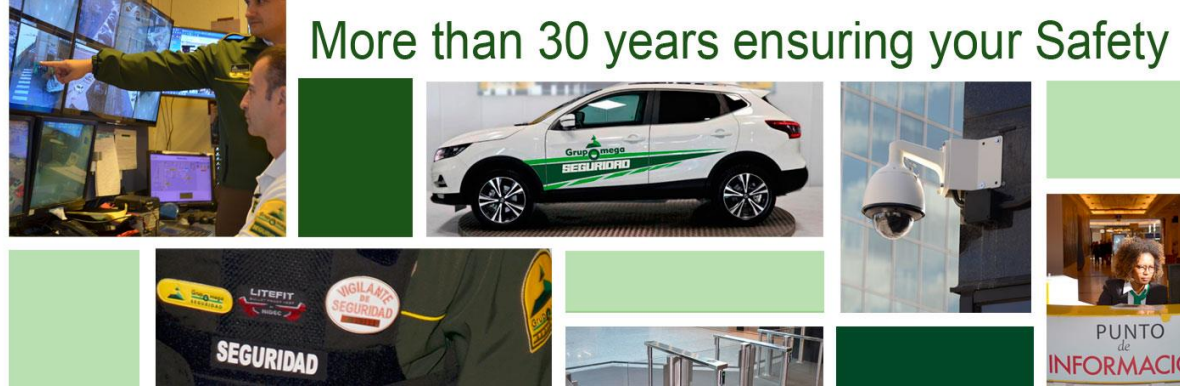
Social engineering as a form of intelligence and counter-intelligence. Principles of social engineering. Social engineering as a method of influence for change and positioning. Social engineering methods and strategies. Prevention of social engineering actions and countermeasures. Advantages and risks.

8.- DIGITAL COMMUNICATION AND SOCIAL NETWORKS

Analysis of social networks: Who is who. Digital surveillance: who and how they talk about you, competitor surveillance, early detection of opportunities and threats and market monitoring. Information dissemination: Make it viral! Big Data and the real world. Detection and management, brand attacks, attacks on the individual for destabilization purposes. Online crisis management: setting up propagation firewalls by channel, by message, by stakeholder. The impact of reputation on the stock market. E-Reputation management as a proactive solution.
